Please refer to the table above for any children taking the stretched offer of 47.5, 51 or 52 weeks. The table above sets the periods funding can be taken between for each term over the academic year. Providers will need to plan and complete a stretched declaration form upfront for each academic year to state the days/weeks they will not be offering stretched funding in each term, for example: 4.5 weeks not offering for the 47.5-week model, and 1 week for the 51-week model.

Please see some examples below of how stretched funding can be taken over the academic year 2025/26 in-line with the parameters of the stretched funding attendance dates above:

## 47.5-week model (Funded – 570 hours)

The above models are common stretched models offered in Derby; however, providers can also choose their own stretched funding models to suit their business, stretching children's yearly funded entitlement of 570 funded or 1140 working hours over anywhere between 38 to 52 weeks, as long as a stretched declaration form is completed and submitted to Derby City Council to show how children's yearly funded entitlement will be stretched for the academic year in line with the stretched attendance dates shown in the table above.
