Equality impact assessment – please read this section first before you do the assessment

This is our equality impact assessment form to help you equality check what you are doing when you are about to produce a new policy, review an older one, write a strategy or plan or review your services and functions. In fact you need to do an equality impact assessment whenever a decision is needed that affects people and **before** that decision is made.

So why do we need to do equality impact assessments? Although the law does not require us to do them now, the courts still place significant weight on the existence of some form of documentary evidence of compliance with the **Public Sector Equality Duty** when determining judicial review cases. This method helps us to make our decisions fairly, taking into account any equality implications, so yes we still need to do them.

The Public Sector Equality Duty is part of the Equality Act 2010 and this Duty requires us as a public body to have '**due regard**' to eliminating discrimination, harassment and victimisation and any other conduct that is prohibited by or under the Act. It requires us to advance equality of opportunity and foster good relations between people who share a '**relevant protected characteristic**' and people who don't.

Having 'due regard' means:

- removing or minimising disadvantages suffered by people due to their protected characteristics
- taking steps to meet the needs of people with certain protected characteristics where these are different from the needs of other people
- encouraging people with certain protected characteristics to participate in public life or in other activities where the participation is disproportionately low.

The protected characteristics are:

- age
- disability
- gender identity
- marriage and civil partnership
- pregnancy and maternity
- race
- religion or belief
- sex
- sexual orientation

This completed form should be attached to any Chief Officer Group, Cabinet or Personnel Committee report to help elected members make their decisions by taking the equality implications into account. Equality impact assessments **must be done before** decisions are made. Include the Cabinet or Personnel Committee's decision on the front sheet when you know it.

You'll find that doing these assessments will help you to:

- understand your customers' and communities needs
- develop service improvements
- improve service satisfaction
- demonstrate that you have been fair and open and considered equality when working on re-structuring
- make sure you pay due regard to the requirements of the Public Sector Equality Duty.

Don't do the form by yourself, get a small team together and make sure you include key people in the team such as representatives from our Diversity Forums and employee networks and you could invite trade union representatives too – the more knowledge around the table the better. You also need to decide how and who you will consult with to help inform the equality impact assessment. Our Lead on Equality and Diversity can help with useful contacts – we have a team of people who are used to doing these assessments and can help with information on barriers facing particular groups and remedies to overcome these barriers.

You'll need to pull together all the information you can about how what you are assessing affects different groups of people and then examine this information to check whether some people will be negatively or positively affected. Then you'll need to look at ways of lessening any negative effects or making the service more accessible – this is where your assessment team is very useful and you can also use the wider community. Against every negative impact you will need to complete the mitigation section to explain how you will lessen the impact.

Agree an equality action plan with your assessment team, setting targets for dealing with any negative effects or gaps in information you may have found. Set up a way of monitoring these actions to make sure they are done and include them in your service business plans.

When you have completed the assessment, get it signed by your Head of Service or Service Director and **send it to our Lead on Equality and Diversity for checking and to publish on our website**. It is a public document so must not contain any jargon and be easy to understand.

Remember, we need to do these assessments as part of our everyday business, so we get our equality responsibilities right and stay within the law – Equality Act 2010.

Equality groups and protected characteristics

These are the equality groups of people we need to think about when we are doing equality impact assessments and these people can be our customers or our employees and job applicants...

- Age equality – the effects on younger and older people
- Disability equality – the effects on the whole range of disabled people, including Deaf people, hearing impaired people, visually impaired people, people with mental health issues, people with learning difficulties and people with physical impairments
- Gender identity – the effects on trans people
- Marriage and civil partnership equality
- Pregnancy and maternity equality - women who are pregnant or who have recently had a baby, including breast feeding mothers
- Race equality – the effects on minority ethnic communities, including newer communities, gypsies and travellers and the Roma community
- Religion and belief or non-belief equality – the effects on religious and cultural communities, customers and employees
- Sex equality – the effects on both men and women and boys and girls
- Sexual Orientation equality – the effects on lesbians, gay men and bisexual people

The form

The Council has a statutory responsibility to prepare a balanced budget for 2019/20. The continued reductions in government funding and increased pressures will inevitably lead to the Council having to reduce spending on the services it delivers.

This consultation was led by Don McLure, Strategic Director of Corporate Resources.

Budget proposals have been consulted on with Strategic Directors and Council Cabinet. Further consultation has been carried out with citizens, scrutiny meetings, business rate payers and with representatives from the Equality Hubs and Forums – the consultation period ran from 13th December 2018 to 24th January 2019.

Budget proposals have been consulted on with Strategic Directors and also the elected members of Council Cabinet.

Proposals have been screened for both financial and service factors to determine whether specific equality impact assessments are required. For the financial assessment, a significance level £200,000 has been set. Colleagues have reviewed proposals and completed initial summary assessments that have identified impact if appropriate.

Peoples Directorate launched a separate consultation to start an early consultation process on some savings proposals as agreed in 24 October 2019 Cabinet Document. This consultation was launched on 9 November and closed on Friday 01 February 2019.

Consultation with colleagues and Trade Unions is continuing regarding the savings from the removal of car parking permits and a separate full EIA will be carried out before any decisions are made. This will be posted to the Council website when complete.

Further consultation has been carried out with citizens, members of scrutiny groups, with business rate payers and with representatives from the Equality Hubs and Forums.

Details of budget proposals are available on line and at local libraries. Feedback was invited through the online survey or by completing a paper questionnaire. The questionnaire was available in other formats on request.

Consultation, scrutiny and equality meetings were held at the Council House, which is accessible for disabled people and BSL interpreters were provided as required.

Due to the size and scope of the budget reductions proposed we know that there is some impact on people with protected characteristics. EIAs have already been completed for the major proposals and will be done for smaller projects – where the impact is negative, mitigating actions have been highlighted in the EIAs.

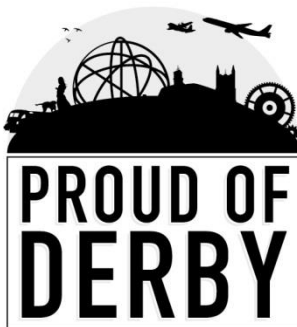
